

# Allied Air Manufacturer Certification Statement Under American Taxpayer Relief Act of 2012

## FEDERAL TAX CREDITS FOR QUALIFIED ENERGY-EFFICIENT HVAC IMPROVEMENTS—RESIDENTIAL NATURAL GAS/PROPANE FURNACE AND OIL FURNACE PRODUCT CATEGORIES

Taxpayers claiming a credit for Qualified Energy Property should retain this Certification Statement for taxpayer records. Under the American Taxpayer Relief Act of 2012, the U.S. Internal Revenue Service (IRS) is implementing consumer tax credits for homeowners who make qualified improvements of higher-efficiency HVAC equipment to their primary residences. Due to a recent reauthorization, tax credits are effective for all qualified energy property systems installed from January 1, 2012 through December 31, 2016.

### CERTIFICATION STATEMENT


